The rider can be issued with our AG Select-a-Term level premium term life insurance, to provide a guaranteed monthly income for a specified period of time in addition to the lump sum death benefit from the base policy. Select Income Rider:

- ▶ Pays a monthly benefit for a period of 60, 120, 180, 240, 300, 360, 420, or 480 months upon the death of the insured
- ▶ Minimum monthly benefit amount is \$500
- ▶ Is available only in conjunction with AG Select-a-Term, and must be issued at the same time
